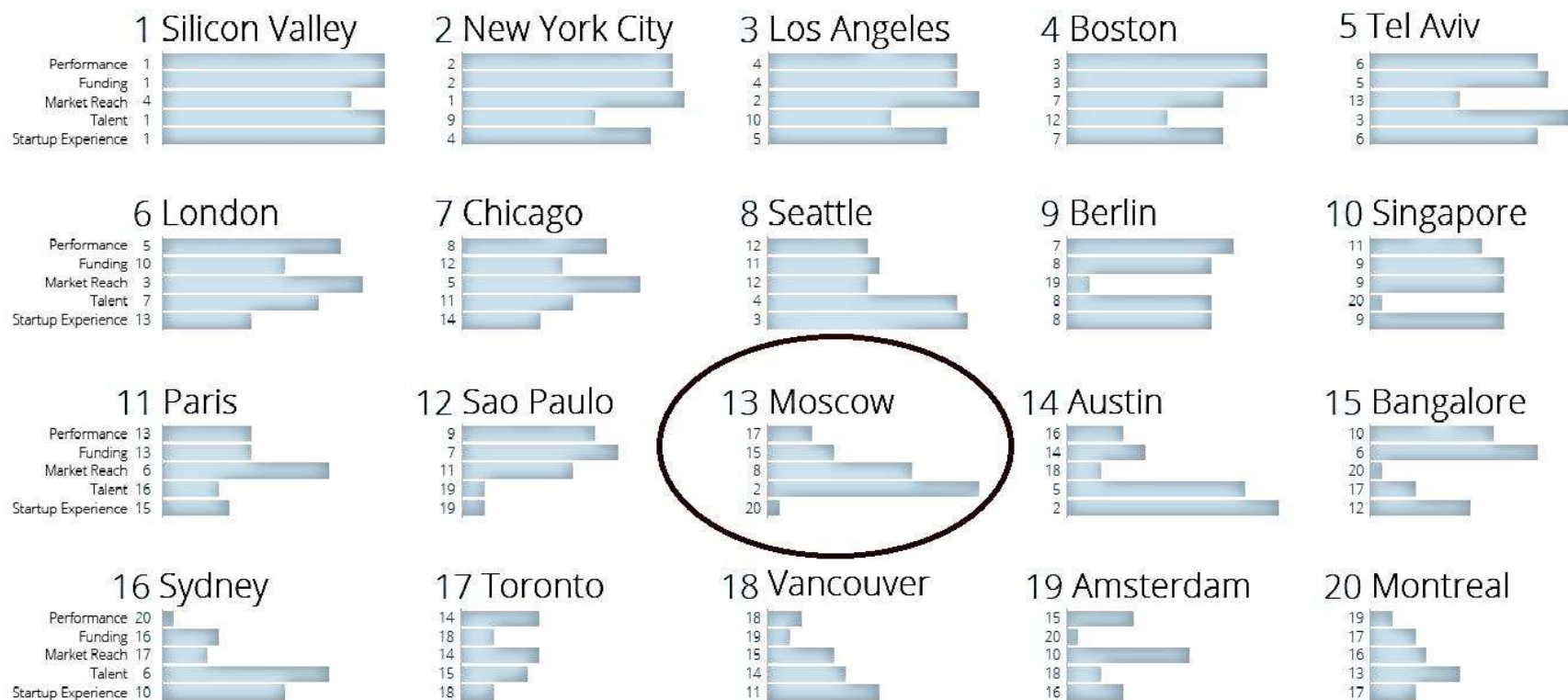

The main objective of the Fund is creating favourable conditions for development of venture investment market in Moscow.



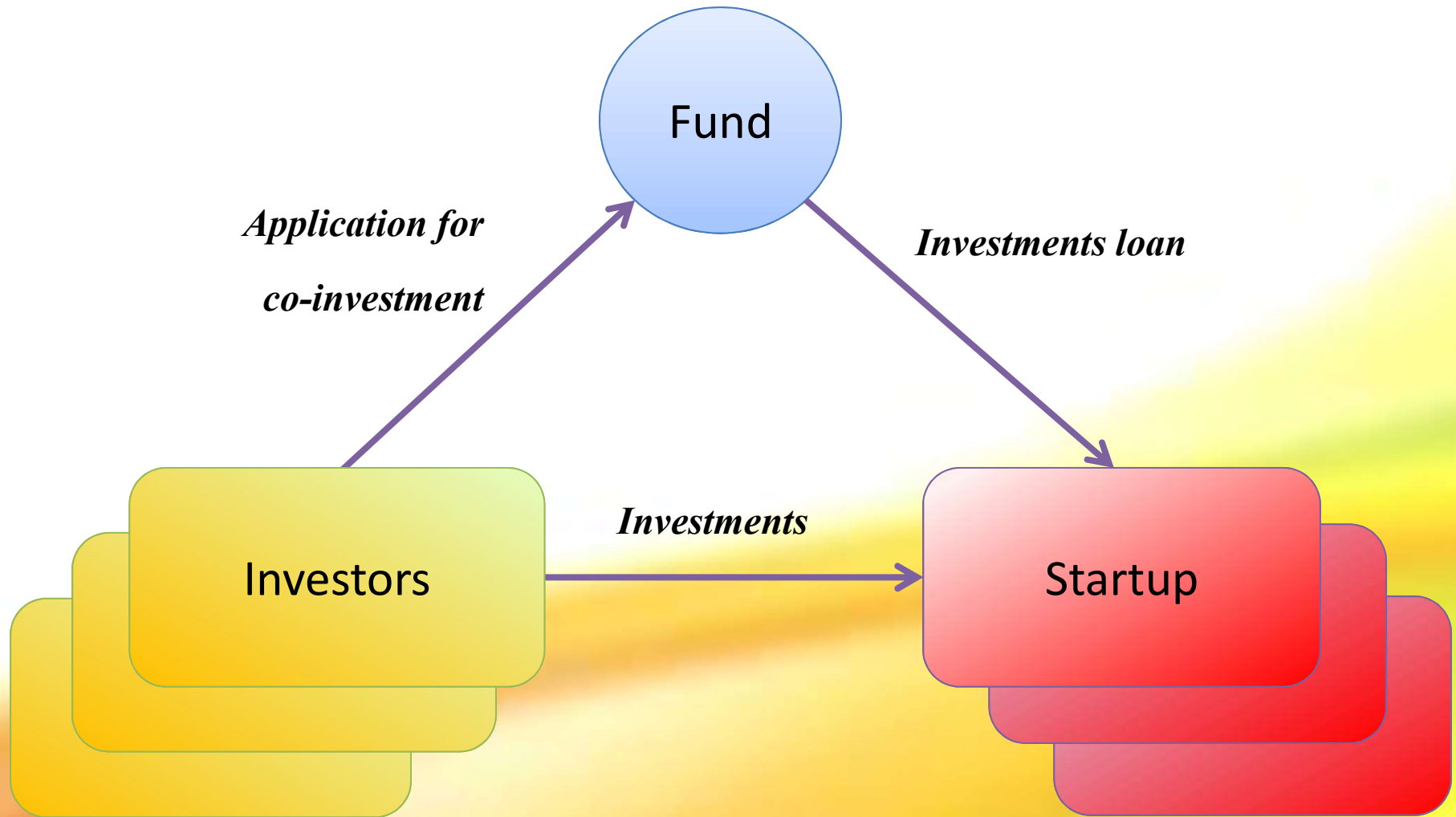
How we work

1. We invite investors to collaboration;
2. The investor finds a new project;
3. The investor and the project makes the presentation for the Fund;
4. The Fund makes a decision to give money or not;
5. The Fund focuses on the opinion of the investor when making the decision;
6. One part of money is given by investor, two parts are given by Fund (on 1 EUR from investor Fund can give 2 EUR);
7. Investing in the early stages of development (100 000-200 000 EUR);
8. An investment loan is used as the main way of funding

Results

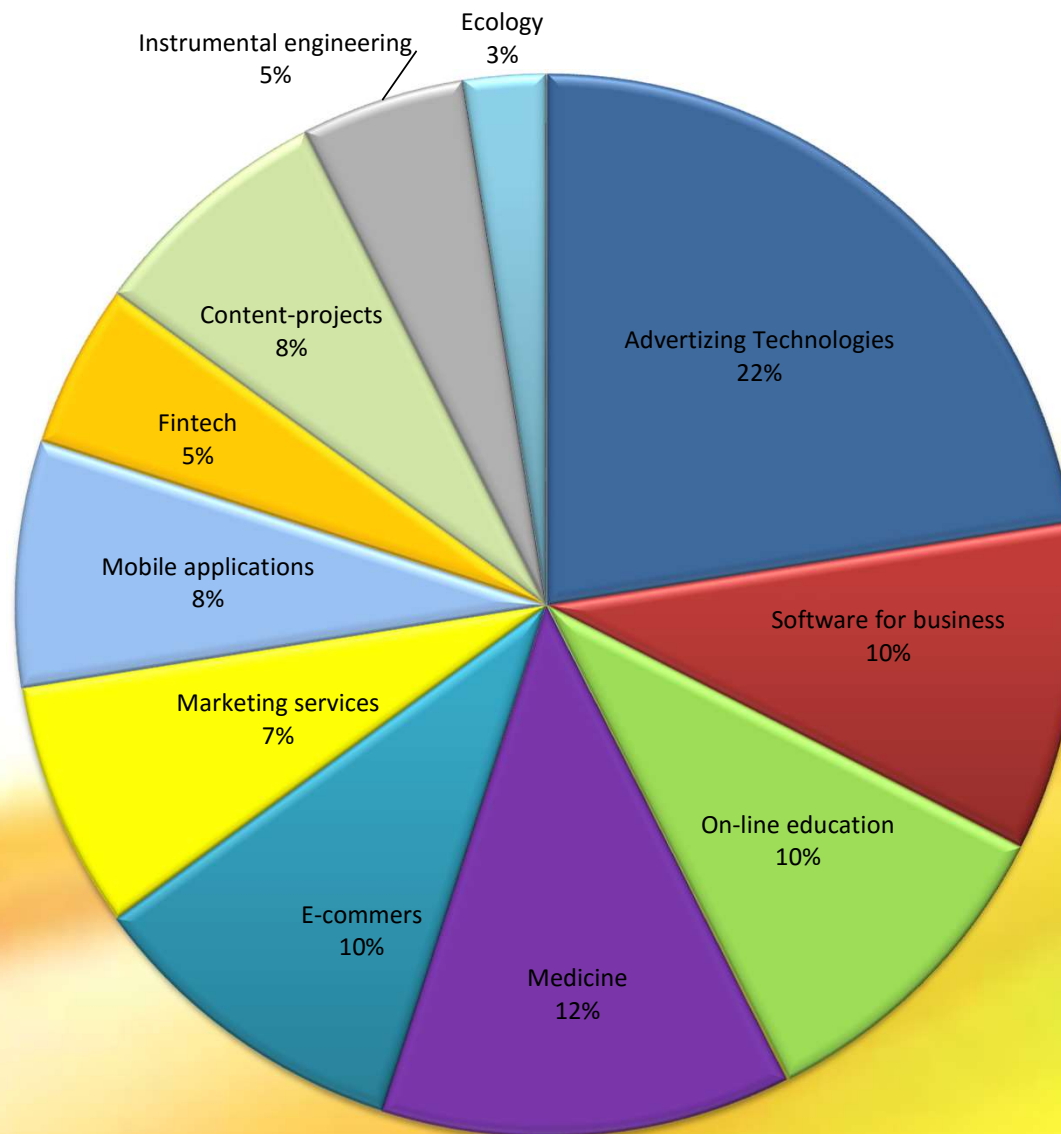
- Our support program is unique in Russia;

- Raised for the next investment round: 536 000 EUR.



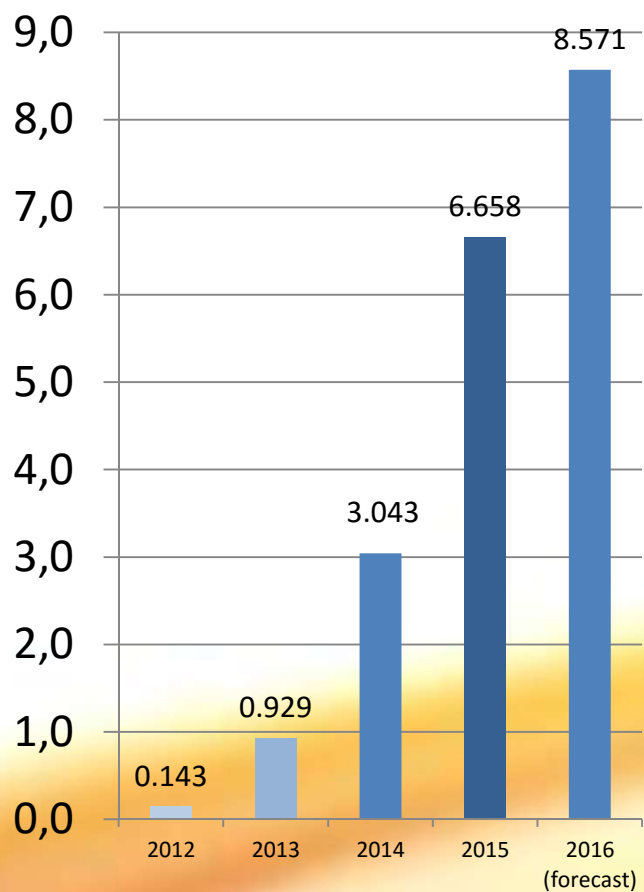
YaClass is engaged in development of remote on-line training system, which contains a base of electronic workbooks and a simulator for the school program

- Investments in the project: 115 000 EUR, project valuation 858 000 EUR.

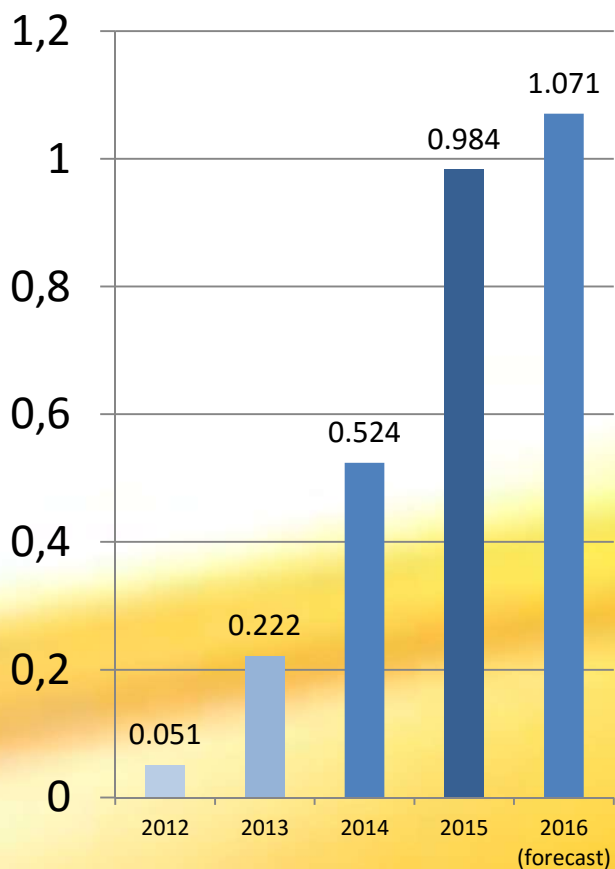


Economic results of the portfolio companies

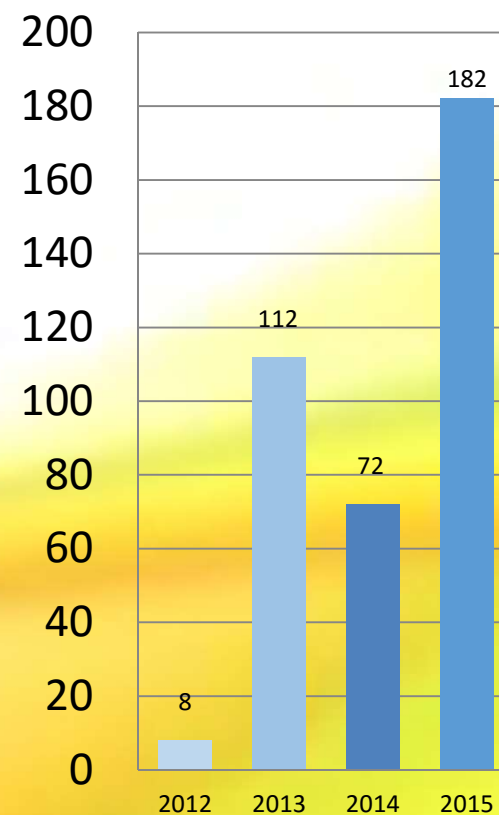
Revenue, mln EUR

New jobs created, persons



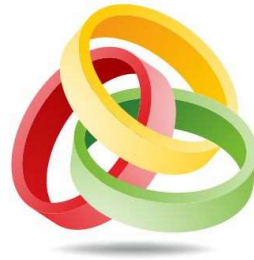
