

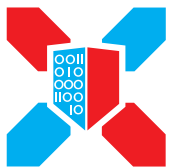

Terms & Conditions

1. By accepting the offer, all participating Companies to the “Luxembourg pavilion” during the FIC 2023 Event are deemed to have accepted these Terms and Conditions.
2. Participant Fees shall be paid by the participating Company within 30 (thirty) days of the invoice date for such fees. In all cases fees shall in any event be paid 5 (five) working days prior to the beginning of the FIC 2023.
3. In case the participating Company fails to meet his payment obligations, LHC shall be entitled in its sole discretion to deem the cancellation of the participating Company to the “Luxembourg pavilion”.
4. In case of withdrawal from this offer, the following cancellation conditions will apply: a) cancellation up to one month before the beginning of FIC 2023, 20% of the participant fee will be retained as administrative costs; b) cancellation up to 2 weeks (14 days) before the start of the FIC 2023, 60% of the participant fee will be retained as administration costs; c) cancellation up to one week (7 days) before the beginning FIC 2023, 100% of the participant fee will be retained as administration costs.
5. It is each participating Company's sole responsibility to comply with all relevant local laws.
6. Each participating Company agrees that if any provision of these Terms and Conditions is deemed to be invalid, the remaining Terms will remain valid, binding and enforceable.
7. The participating Company grants LHC a non-exclusive, non-transferable, royalty-free, revocable, worldwide license for the period of time between the date of the acceptance of this Offer and the end of the FIC 2023, to use the participating Company's logos solely and strictly for the purpose of reasonably promoting, marketing and advertising the “Luxembourg Pavilion” participation in the FIC 2023.
