 - **All-risks insurance** to provide coverage to your exhibition material for the transport to and from the place of trade fair, for the installation and dismantling period as well as for the duration of the exhibition.
 These insurances include a clause to waive the exercise of any recourse claims against the Chamber de Commerce of the Grand-Duchy of Luxembourg.
