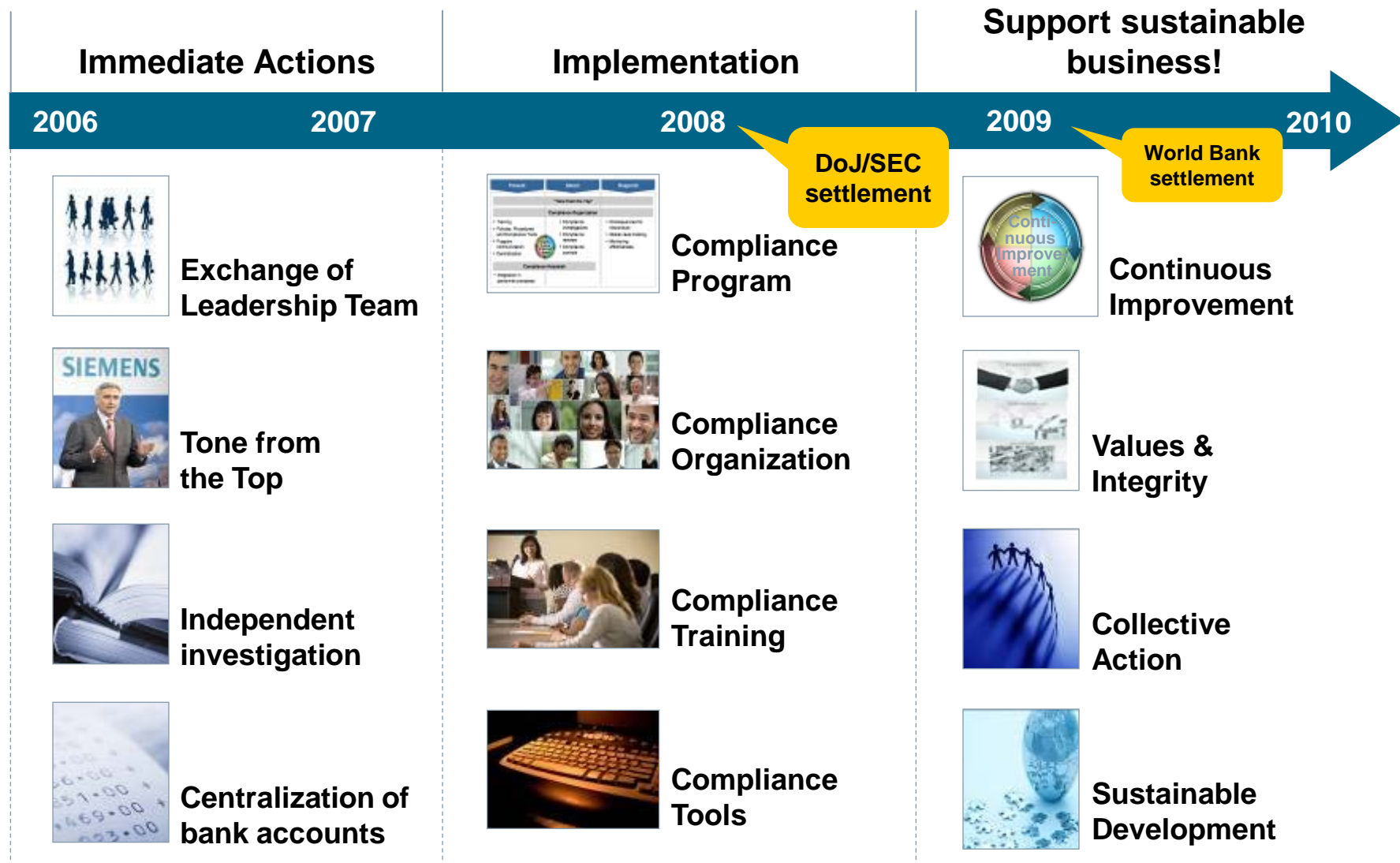

Energize market dynamics, fair competition and business environment

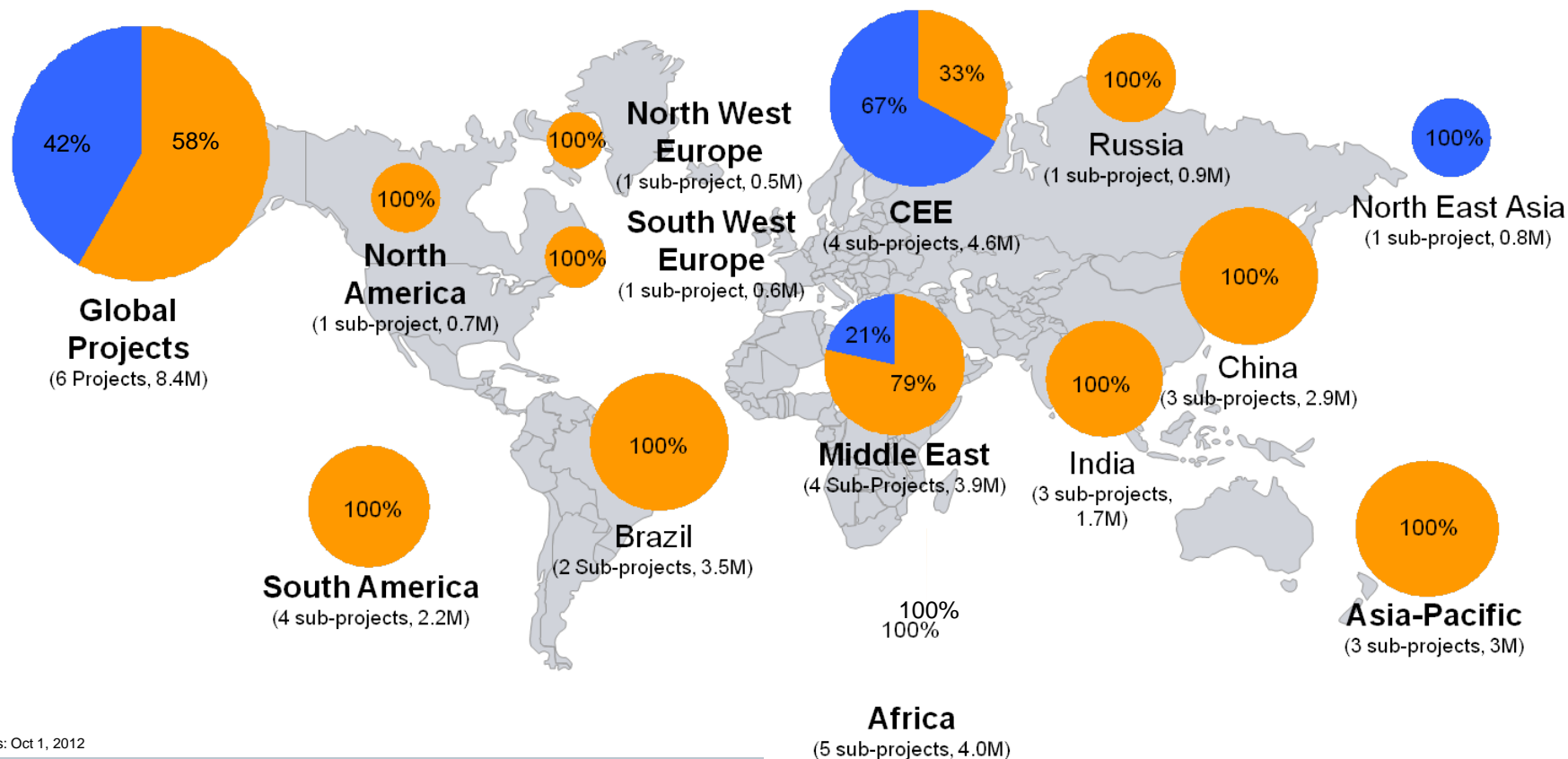

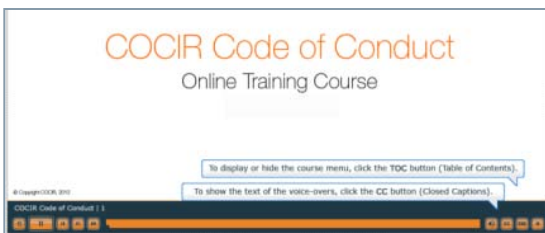
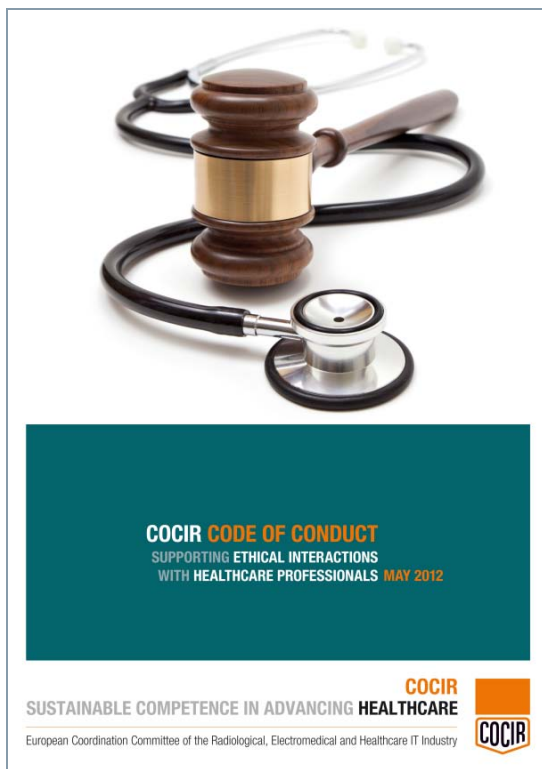
## Key Information

- Funding Volume: USD 0.45M over 3 years
- Country of implementation: Bulgaria
- Objective: Enhance integrity standards and transparency in awarding of contracts with significant public interest, through policy change in Bulgaria

## Project Main Activities to date (2010-2012)

- Analysis of deficiencies of the Bulgarian legislation and assessment of public contracting procedures
- Recommendations for legal amendments and changes in procurement practices developed jointly with state institutions, local governments, the private sector and business associations
- MoUs were signed with Ministry of Health (MoH), the Ministry of Labour and Social Policy (MoLSP) and the Ministry of Regional Development and Public Works. (MoRDPW) for implementation of Integrity Pacts
- Development of a White List in public procurement which is published on the TI Bulgaria website

# COCIR Code of Conduct – Training and regional expansion to emerging markets

- Within the framework of the Siemens Integrity Initiative, **one million US-dollars** go to COCIR (over three years)
- **COCIR is the European Coordination Committee of the Radiological, Electromedical, and Healthcare IT Industry**
- COCIR developed a **Code of Conduct for Europe** in 2009 that regulates business transactions between its member companies and persons working in the healthcare industry
- The COCIR Code now includes **guidance** in the form of Q&As and Do's & Don'ts and is available in Dutch, English, French, German, Italian and Spanish languages
- In January 2013, COCIR launched the **interactive e-learning tool (WBT Tool)** to complement its Code of Conduct.
- In March 2013, roll-out of the **WBT Tool within Siemens** as a recommended **voluntary training**
- A **regional expansion** of the COCIR code of conduct has been initiated (Argentina, China, India, Russia)

- Objective: Develop and coordinate Collective Action initiatives and bring together stakeholders to agree on and implement sector-specific anti-corruption standards

## Project Main Activities to date (2011-2012)

- Pilot-testing of the [High Level Reporting Mechanism](#) (informal complaint mechanism on country-level) in Colombia
- Launch of the International Center for Collective Action ([ICCA](#))
- [Publication](#) of a book on „Collective Action“ at the Int. Conference on Anti-Corruption / Brazil
- Supported on-going negotiation of framework agreement for companies on Collective Action in high-risk markets

## Key Information

- Funding Volume: USD 3.11 M over 5 years
- Country of implementation: Brazil
- Objective: Promoting transparency and integrity for the 2014 World Cup and the 2016 Olympic Games through Collective Action, social monitoring and control mechanisms

## Project Main Activities to date (2011-2012)

- Discussed sectoral anti-corruption agreements with selected companies in healthcare and construction sector
- Set up 3 national committees on Collective Action and 12 local committees in 12 host cities to watch public tenders
- A Local Administration Transparency Pact was developed and is adhered to by 11 of the 12 host cities for the Games
- 11 public events based on the theme “World Cup and the elections – what is the legacy for you city?”, were organized

- New [methodology](#) on reduction of corruption risks in the public procurement for municipalities was published
- [Webpage](#) of the Coalition for Transparent Business in the Czech Republic was launched

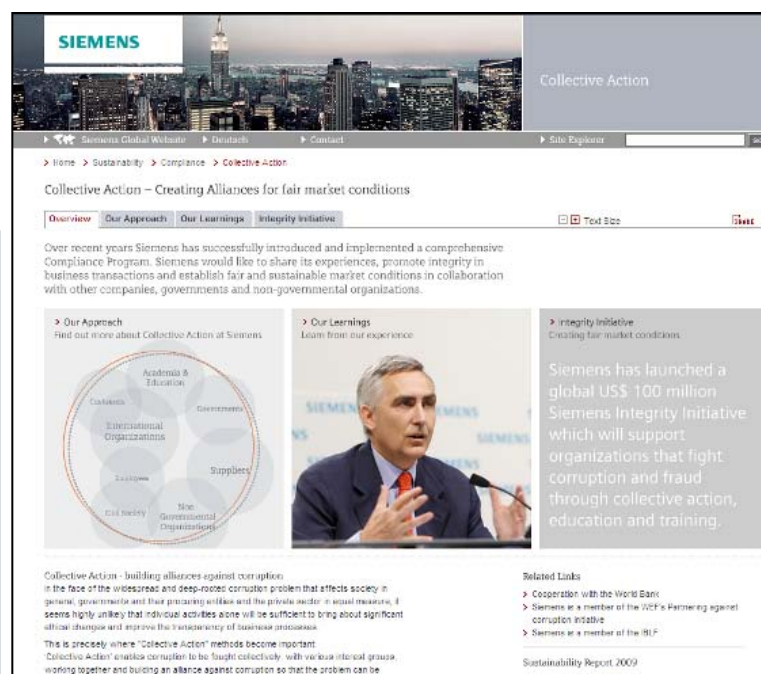
The **Industrial Company Working Group (ICWG)** aims at making tender procedures in Moscow more transparent

- Discussed challenges in the existing public procurement procedures and prepared recommendations
- Studied the tendering experience of some big corporations
- Siemens Russia is a founding member and active driver of the Initiative
