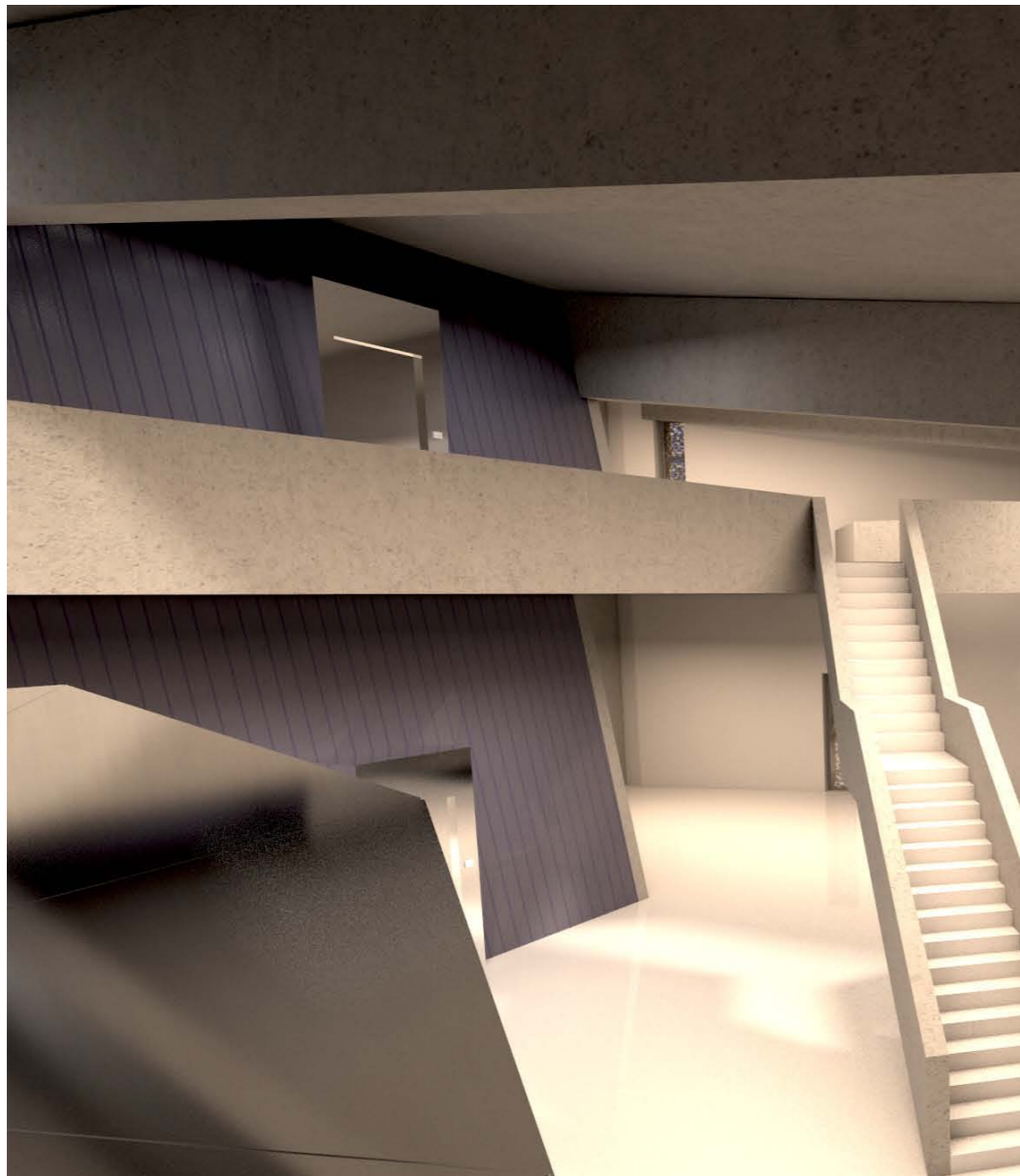

# The Luxembourg Freeport

## The Concept – General

---



- A sophisticated, ultra-safe platform for storage, handling and trading of valuable goods under a tax friendly environment.
- The Luxembourg Freeport will be operated by agents and forwarders specializing in the transportation, handling and storage of valuable goods who will be:
  - Tenants of the Freeport,
  - Licensed by the Luxembourg Customs Authorities (Administration des Douanes et Accises – ‘opérateurs agréés’).
- The end customers of The Luxembourg Freeport are:
  - Banks,
  - Collectors,
  - Museums,
  - Professional investors,
  - Investment funds,
  - ...



# The Luxembourg Freeport

## The Concept – Legal & Tax framework (1)

---

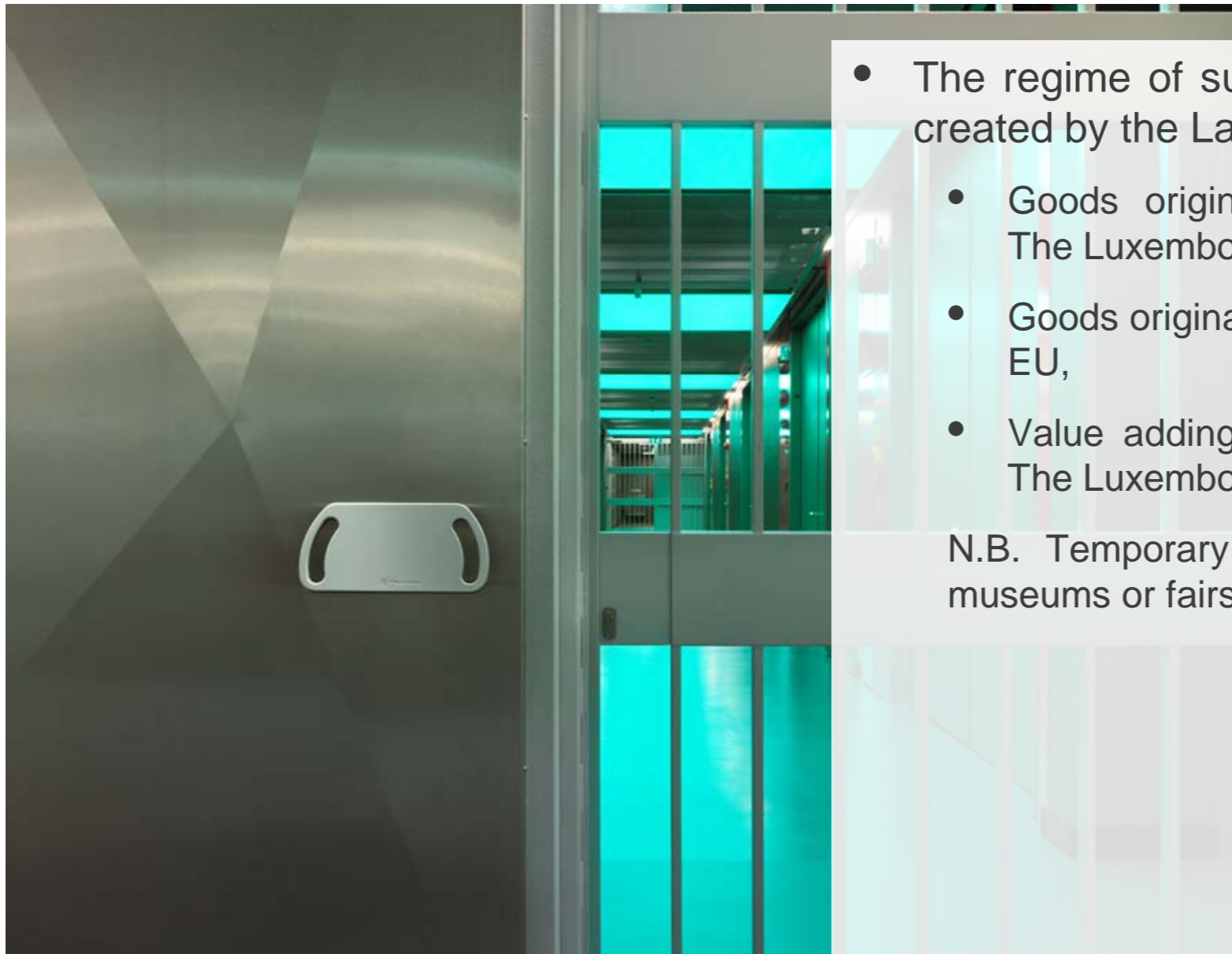


- The Luxembourg Freeport is part of the Luxembourg territory:
  - All Luxembourg laws apply including anti-money laundering laws.
- The Law of 28 July 2011 enabling ‘freeport activities’ is consistent with European Law.
- The Luxembourg Freeport is operated under the supervision of the Custom authorities:
  - Customs are physically present at the Freeport,
  - Their office overlooks the ‘air side’ and ‘land side’ delivery bays,
  - The Freeport is open for business only when Customs are present,
  - All entries and exits of goods must be advised to Customs,
  - Operators must hold detailed inventories and are subject to Customs inspection.

# The Luxembourg Freeport

## The Concept – Legal & Tax framework (2)

---



- The regime of suspension of VAT and Custom duties created by the Law of 28 July 2011 applies to:
    - Goods originating outside of the EU imported into The Luxembourg Freeport,
    - Goods originating in the EU and exported outside of the EU,
    - Value adding services while goods are in storage at The Luxembourg Freeport,
- N.B. Temporary imports for purposes of exhibitions in museums or fairs are allowed



# The Luxembourg Freeport

## The Concept – The Location

---



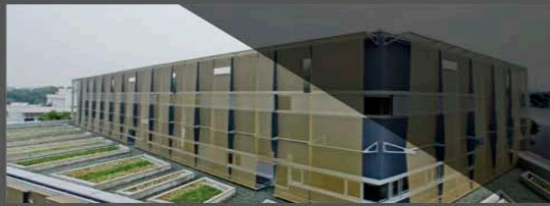
- The Luxembourg Freeport is being built at the Luxembourg airport
  - Construction works have commenced.
  - The Facility is to be completed by September 2014 and opened for business around that date.
  - The Freeport is adjacent to the air cargo terminal.
  - The runway is approximately 750m away.
  - The Freeport will have both an 'air-side' and a 'land-side' access.
  - The Freeport will be at 371m above sea level.
  - There are no rivers or creeks in the vicinity, hence no risk of floods.
  - The country is land-locked and has no history of earthquakes, tornados, hurricanes, devastating storms/hails.
  - Luxembourg is a founding member of the EU, AAA-rated and enjoys social and political stability.

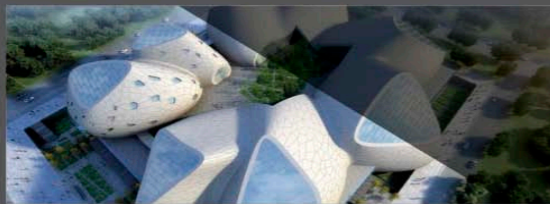

# The Luxembourg Freeport

## The Concept – A sophisticated, ultra-safe storage (1)



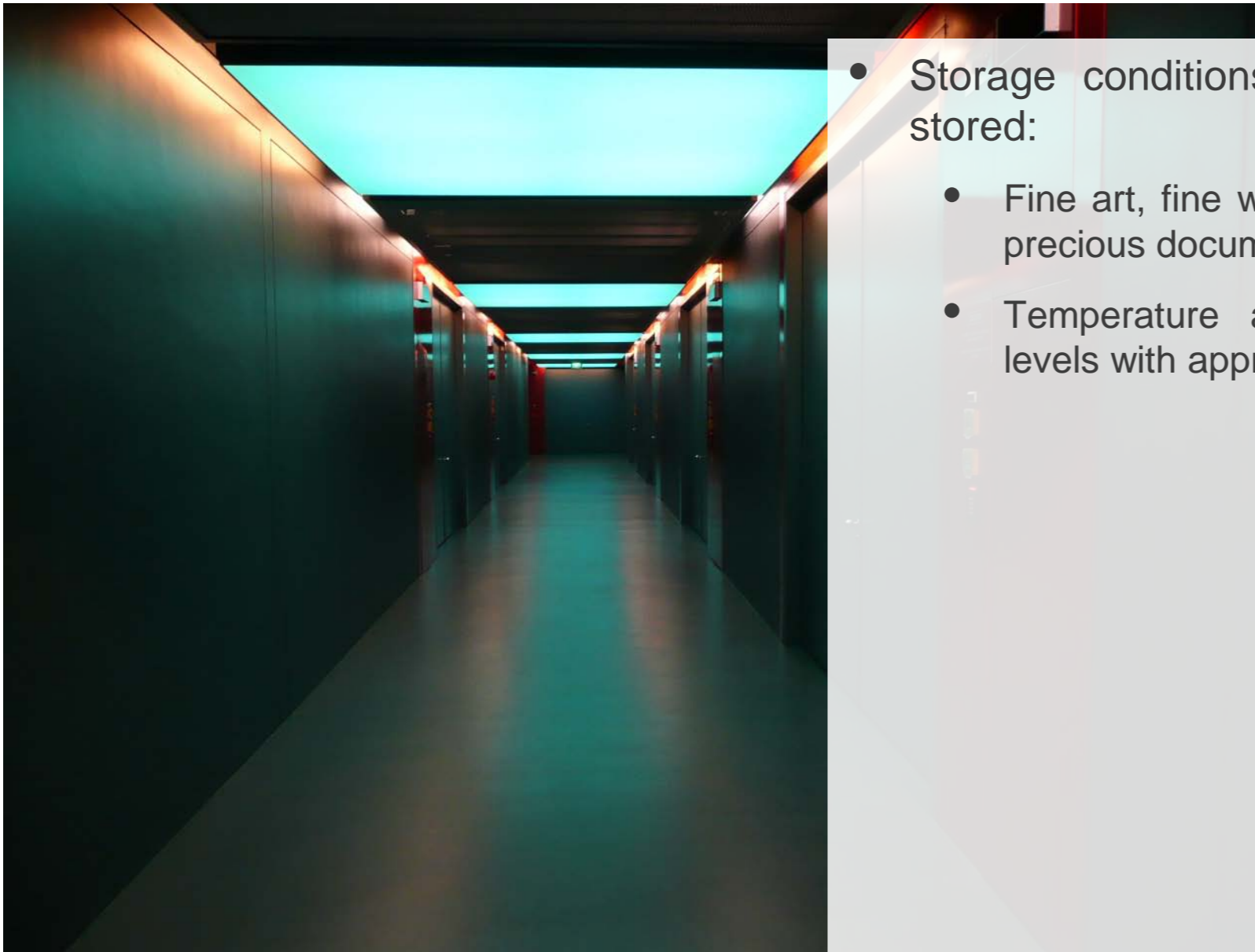
### • Security

- All vehicles accessing the property will be inspected,
- All persons accessing the property and their belongings will be systematically scanned,
- 24 hours/ day, 7 days/ week, 365 days/ year security guards on premises,
- The property will be ring-fenced,
- The surveillance system will feature around 300 CCTV cameras located around the property and in the hallways,
- Access to storage and strong rooms by biometric reading.

# The Luxembourg Freeport

## The Concept – A sophisticated, ultra-safe storage (2)

---



- Storage conditions adapted to each type of goods stored:
  - Fine art, fine wines, precious metals, antiques, jewels, precious documents, digital works of art ...
  - Temperature and humidity maintained at constant levels with appropriate redundancy systems.

# The Luxembourg Freeport

## The Concept – An efficient forum for trading

---



- The Luxembourg Freeport will be particularly well suited to host transactions regarding stored goods:
  - On-site scientific laboratories will provide the necessary comfort regarding the authenticity of the work,
  - There is no withholding tax on capital gains,
  - Depending on the destination of the goods sold there is no VAT on the transaction value,
  - The buyer will be able to use the logistic infrastructure of the Freeport to ship the purchased goods anywhere in the world.



# The Luxembourg Freeport

## The Concept – A One-Stop Shop

---



- In addition to optimal storage conditions adapted to each type of valuable good, the following value adding services will be offered on premises:
  - Customs formalities related to import/export of goods,
  - Crating/Packaging for transportation of goods,
  - Framing of paintings and photographs,
  - Restoration of works of art and antiques,
  - Expert opinion on origin and history of work,
  - Photographing for catalogues etc.,
  - Art Collection Management,
  - Insurance,
  - Display of works in state-of-the-art showrooms...
