### Analysis of your current situation

Make an appointment with the House of Entrepreneurship of the Chamber of Commerce or the eHandwierk department of the Chamber of Skilled Trades and Crafts for a pre-analysis of your current situation in terms of sustainable development to identify priority actions.

#### Definition of your package and choice of service provider

You get to choose your package and the service provider that best meets your expectations. Together, you define a quote for an amount between €6,650 (VAT excluded) and €25,000 (VAT excluded).



## Submitting and reviewing your application

Your application is completed by a House of Entrepreneurship adviser or by an eHandwierk adviser for craft businesses. Your request is submitted to the Approval Committee, which analyses and makes a decision on your application.

Once your application has been approved, you can proceed to approve the estimate and carry out the project.

The service provider implements the sustainable solution according to the chosen package.

#### Assessment of your package

Once the service provider has finished providing support, an evaluation meeting will determine your level of satisfaction and savings made. At that point, the application process will be deemed closed.

#### Your voucher

The final bill is paid to the service provider. The General Directorate for Small and Medium-Sized Enterprises of the Ministry of the Economy will provide you with a grant of €5,000.
